1. The Government of Nepal *[GoN]* has allocated funds towards the cost of **Sano Duduwa RCC Box Bridge** Construction work and intends to apply part of the funds to cover eligible payments under the Contract for **01/073-074** construction of RCC Box Bridge work. Bidding is open to all eligible Nepalese Bidders.
2. **Kohalpur Municipality, Office of the Municipal Executive, Kohalpur** invites sealed bids or electronic bids from eligible bidders for the construction of Sano Duduwa RCC Box Bridge work under National Competitive Bidding procedures.  
Only eligible bidders with the following key qualifications should participate in this bidding:  
Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 13,100,000.00 (One Crore Thirty One Lakhs only)** excluding VAT.  
Minimum Work experience of similar size and nature: at least one Contract with the value of NRs 6,000,000.00 (Sixty Lakhs only) excluding VAT within last ten years.
3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Kohalpur Municipality, Office of the Municipal Executive, Kohalpur-11, Banke** or may visit PPMO website [www.bolpatra.gov.np](http://www.bolpatra.gov.np).
4. A complete set of Bidding Documents may be purchased from the office **Kohalpur Municipality, Office of the Municipal Executive, Kohalpur-11, Banke** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of **3,000.00** till 17.00 hours on **2074/01/05**. However the employer will not responsible for delay or non delivery of the document so sent.

Or

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site [www.bolpatra.gov.np](http://www.bolpatra.gov.np). Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's **revenue account no. 0720501000235063 maintained at Agricultural Development Bank branch office Kohalpur or cash receipt from revenue section of Kohalpur Municipality** as specified below and the scanned copy (pdf format) of the Bank deposit voucher / cash receipt shall be uploaded by the bidder at the time of electronic submission of the bids. 5. Pre-bid meeting shall be held at **Kohalpur Municipality, Office of the Municipal Executive, Kohalpur, Banke at 11:00 hours on 2073/12/28. The bidder or his authorized representative is encourage to attend the pre-bid meeting. The purpose of meeting is clarify and issue regarding the bid document and to demonstrate the process of e-submission and opening of bid.**
6. Sealed or electronic bids must be submitted to the office of **Kohalpur Municipality, Office of the Municipal Executive, Kohalpur-11, Banke** by hand/courier or through PPMO website [www.bolpatra.gov.np](http://www.bolpatra.gov.np) on or before 12:00 Hours on **2074/01/06**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 Hours on 2074/01/06** at the office of **Kohalpur Municipality, Office of the Municipal Executive, Kohalpur, Banke**. Bids must be valid for a period of **90 Days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs 206,000.00 (Two lakhs six thousand only)**, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
